In October 2013, France's constitutional court upheld a law prohibiting fracking for shale gas. The French environment minister described it as "a judicial victory but also an environmental and political victory". Further developments include discussion over a bill that aims to integrate the concept of "ecological damage" in the civil code. In this chapter, we identify 18 lawyers.
